Section L

Volunteer Policy & Profile

Big Brothers - Big Sisters and Connect-4 Group Mentoring are social service programs designed to help young people who have shown a need for a strong relationship with an interested adult. While the programs are interfaith and interracial ones, the desires of the young person's parent or guardian are respected in the selection of the appropriate adult or 'captain' for each young person.

Information for Big Brothers Big Sisters Applicants:

In determining whether an applicant may be considered for a match and the extent to which information shall be communicated to both parties, due consideration is given to past and present factors in the health, personality and behaviour of each individual and/or family constellation. The YWCA of Adelaide may deem certain information as having the potential to affect the relationship adversely if revealed at an inappropriate time. While relevant information shall be provided, the names of the parties described shall be held confidential before a match is made. Any party has the right to refuse to enter into the match based upon the information so communicated.

The screening and selection process (e.g. interviews, police check) are designed to establish a profile of you and your interests. This profile will be used by the YWCA to best match you with a 'Little'. As a volunteer, your profile will be kept in the strictest confidence prior to being matched. However, relevant information relating to your profile may need to be shared with the parent or guardian (who has responsibility for the little or crew member) as deemed appropriate by the worker. Please inform the YWCA of Adelaide if there is any personal information about your profile that you would prefer not to be shared with the parent/guardian. A similar profile of the young person and the family will be discussed with you prior to matching, to ensure that your desires are respected.

Information for Connect-4 Group Captains:

You will receive a very basic profile about the members of your crew prior to and during the activity. Personal information about your profile will not be shared with the parent/guardian unless the program staff feel that it is imperative that they know certain details and we will discuss this with you first instance. You are not permitted to give the young people your contact details. Equally, you are not permitted to see the young people in an unsupervised environment unless the worker has specifically organised you to assist with transport for the activity.

Section M

Privacy Notice

All personal information will be collected and handled by the YWCA of Adelaide in accordance with our Privacy Policy. If you have not been provided with a copy of this policy, please ask for one.

Collection

The personal information (including sensitive and health information) that is collected by the YWCA of Adelaide is information necessary for its functions and activities. In particular, it is necessary to:

- a) Assess suitability
- b) Establish matches
- c) Promote health and safety
- d) Promote the best interests of the child; and
- e) Protect the longevity of matches

Section N

Authorisation for Release of Personal Information

I agree, as a condition of my engagement as a volunteer with the YWCA of Adelaide that:

- In relation to my application for this position, the YWCA of Adelaide will collect personal and sensitive information as part of the application process and, from time to time, during my engagement as a volunteer. This will include the YWCA of Adelaide undertaking a National Criminal Record Check.
- All personal and sensitive information collected by the YWCA of Adelaide as part of the application process is for the purpose of determining whether applicants are suitable to work with young people and to enable the YWCA of Adelaide to retain appropriate information to deal with any future legal liability which may arise in relation to its volunteers' work with young people
- I authorise any agencies, individuals or other entities such as (but not limited to) past or present employers, educational institutions, law enforcement agencies, social services and other such entities with which I have had contact, to release any information about or relating to me as requested by the YWCA of Adelaide.
- I may access my personal information at any time by contacting the YWCA of Adelaide.
- If my application is successful, the YWCA of Adelaide will retain my personal information for the duration of my engagement as a volunteer and for the life of the file, which may be up to 100 years. If my application is unsuccessful, the YWCA of Adelaide will securely dispose of all personal and sensitive information relating to my application after 12 months.
- I acknowledge that collection and retention of my personal information is required as a condition of my engagement with the YWCA of Adelaide and the YWCA of Adelaide may refuse my application or terminate my engagement as a volunteer if my consent is not provided.
- I understand that I am required to inform the YWCA of Adelaide of any changes to my circumstances during involvement in the program.
- I agree that a photocopy of this authorisation is sufficient evidence of my consent to the release of any information about or relating to me to the YWCA of Adelaide.
- Where I provide personal information about other people, I must ensure that those people are aware that this information is being collected and used by the YWCA of Adelaide for its functions and activities.
- I am aware that use of my own vehicle is at my own expense and risk. Whilst the YWCA of Adelaide has public liability and volunteer accident insurance for volunteers, this does not cover damage to my car or that of a third party, nor does it cover what is included in Third Party (bodily) insurance (compulsory with car registration in SA).
- I give the agency permission to use information about my involvement in the program for research and evaluation purposes.

Disclosure

Generally, your personal information will be kept in the strictest confidence. However, relevant information will be released in limited circumstances where:

- a) Disclosure is consistent with the primary purposes for which the information was collected;
- b) Where you have provided your consent to the disclosure of such information; or
- c) Where the law otherwise requires or authorises us to disclose that information.

For example, your personal information may be disclosed to parents/guardians with a direct responsibility for a young person, who has been pre-screened and is actively being considered for a match with you. Your name will be kept confidential until you are matched to the young person.

We may also provide personal information about individuals to others who assist us in providing services, including (amongst others) legal or professional advisers. Unless you contact us to request otherwise, your personal information will be included in the Big Brothers Big Sisters volunteer database hosted in Canada.* Our database provider has committed to complying with Canadian privacy laws, which may differ from Australian privacy laws.

*Our database provider is the Canadian Outcomes Research Institute (CORI), a not for profit charitable organisation, which also supports BBBS Canada. BBBS Australia has viewed CORI's Privacy Policy and is satisfied the personal information of participants will be protected in accordance with Canadian privacy laws.
